# Vitches of Old


Witches are popular in today's culture and are celebrated mostly on Halloween. However, long ago, things were much different for witches than they are today. Back then, witches were classified as those who called upon spirits, practiced witchcraft, or used magic spells. Most people viewed witches as evil, and it was thought that they were doing the Devil's work. In reality though, many of those termed 'witches' were simply 'wise women' who used natural substances to heal.

#### **Earliest Record of Witches**



The earliest recorded account of witches is actually found in the Bible. In 1 Samuel, the bible tells a story about King Saul seeking out the Witch of Endor to summon the dead prophet of Samuel's spirit. He thought that if he spoke to Samuel's spirit, they could defeat the Philistine Army (History.com). Additionally, in Exodus 22:18, it states "thou shall not suffer a witch to live". a seall

#### Witch Trials -3

In 1647, Alse Young was the first American to be executed for witchcraft in Windsor, Connecticut. Over the next 50 years, fortysix people would be accused of being witches in Connecticut, of which 11 of them would be put to death.

In 1692, amidst war between the French and the British, a smallpox epidemic and continual fear of attacks from Native American tribes, the Salem Witch Trials began. When Elizabeth Parris (9 yrs. old) and Abigail Williams (11 yrs. old) both suddenly began suffering from body contortions and uncontrolled screaming, and many more began exhibiting the same symptoms, mass hysteria ensued. Three women were accused of being responsible for the sudden afflictions, including Sarah Good, Sarah Osborn



and Tituba, an enslaved woman who was owned by Elizabeth Parris's father (History.com). It was Tituba who openly confessed to being a witch and accused others of also being witches and practicing black magic. By the time the Salem Witch Trials were over, 150 people had been accused of using witchcraft, of which 18 (6 men, 12 women) were found guilty and put to death.

Today, witches still struggle to rid themselves of the historical stereotype. Witches live among and around us, though you would never be able to tell them apart from regular people. They do not stand over black cauldrons of green goo, ride on a broomstick, or wear a pointy hat, although some still might. Throughout history, witches have instilled fear among those around them. So, on Halloween this year, don't be surprised if you spot a real witch or two.

# Pumpkin Delight

#### Ingredients:

1 cup all purpose flour

- 1/2 cup butter, softened
- <sup>3</sup>⁄<sub>4</sub> cup pecans chopped
- 8 oz cream cheese, softened
- 1 cup powdered sugar
- 3 cup whipped topping divided

2<sup>1</sup>/<sub>2</sub> cup milk

3 pkgs white chocolate (or vanilla) instant pudding mix (3.4 oz size)

15 oz can pumpkin puree

1 tsp pumpkin spice

#### **Directions:**

- 1. Mix flour, butter and ½ cup pecans together. Press into a sprayed 9x9 or 9x13 pan. Bake for 15 minutes at 350 degrees, then remove and let cool.
- 2. Blend cream cheese and powdered sugar, add 1 cup of the whipped topping, then spread over cooled crust.
- 3. Mix milk, pudding mix, canned pumpkin, pumpkin spice and 1 cup whipped topping until smooth. Spread over top of layer 2.
- 4. Spread remaining 1 cup of whipped topping and sprinkle pecans.
- 5. Let chill for 3 hours or until set. Serve chilled, and ENJOY!
